

During 2005, I served as General Secretary-Treasurer of the International Union of Operating Engineers (IUOE) from January 1, 2005 through February 28, 2005. Effective March 1, 2005, I became General President of the IUOE.

Continuation, page 2 of 3, extended answer to question 14(a).

During 2005, I served as Chairman of the Board of Directors of Horizon Blue Cross Blue Shield of New Jersey (Horizon BCBSNJ), a non-profit organization providing health care services. As Chairman of the Horizon BCBSNJ Board, I presided over numerous meetings of the organization's Board of Directors, as well as similar meetings of related entities and chaired various Committees of the Board; I also served the organization in other leadership capacities, including officially representing the organization at certain business and charitable functions. For my services to the organization, I received a total of \$181,900.08 in compensation, which was provided in the following amounts from three entities that are part of the greater Horizon organization: 1) Horizon Health Care Services, Inc.—\$173,500.08; 2) Horizon Healthcare Plan Holding Company, Inc.—\$6,000.00; and 3) Enterprise Holding Company, Inc.—\$2,400.00. Horizon has also advised that my pro rata portion of a Board holiday event and dinner on 12/7/05 was estimated at \$200.
